#### Item No.Q3.18.03: Report on Massive Online Open Course (MOOC)

MOOC has silently entered our higher education sector. Many students of higher education sign up for courses offered through world-class Universities over platforms such as Coursera, Edx etc and some have even moved closer to receiving micro and nano degrees by accumulating credits from these. Courses of diverse variety are available online, starting from "Being Happy" to "Death". While students may sign up for subject related courses, laymen have wide variety to choose from including magic, soft skills, foreign languages, gardening and cooking. In India, the central Govt. has created a platform christened SWAYAM through which MOOC courses are offered and students can sign up for the courses and transfer the credit to their University programmes. The UGC regulations in this regard have been implemented in University of Kerala, though it is not known if any student has utilized the opportunity. Many successful courses in international

platforms are of short duration and not meant to be a part of academic certification. SWAYAM has a suite of courses, each of which caters to syllabi of Degree programmes and involve online listening of dozens of hours of lectures.

IQAC has successfully run a MOOC certificate course on "How to make a powerful multi-media presentation" involving six 6-minute lectures and 4 quizzes and 2 assignments. Out of the 568 registered students who took the course in the first go, 8 were from UAE, 3 each from Kuwait and Malaysia, 2 from USA and 1 from Madagascar, Canada, Sweden, Australia. Among registrants from India, about 90% are from Kerala. The rest includes Tamil Nadu, Andra Pradesh, Orissa, Delhi, Maharastra, Gujarat, Uttar Pradesh, Lakshadweep and Pondicherry. The first course ran from May 2nd 2017 to June 12th 2017. Nearly 82 students bagged course completion certificate. Dr. Achuthsankar S. Nair was the course lecturer. Dr. Biji C. L, project staff in the Department was the course assistant. The successful conduct of the first MOOC is reported to the IQAC. A detailed report of the same will be tabled.

**Decision:** IQAC appreciated the achievement and resoled to circulate the report to all Departments and to call up on all teachers to consider offering MOOCs either is the style of the pilot MOOC or through SWAYAM. Such digital initiatives are most required in current times.

# Item No.Q3.18.04: <u>Interim Report of Examination Reforms Committee</u> (Questioning the Questions)

Examination reforms committee constituted by the IQAC has submitted its interim reports on scientific analysis of University examination question papers of the teaching Departments (in 3 volumes). The report gives a critical and scientific analysis of the examination instruments which provides a resource base for improvement of examinations. The reports will be tabled. It is proposed that the brief format report may be reprographed and distributed to all teachers, as recommended by the committee.

**Decision:** IQAC discussed the report in detail and resolved to accept the report and noted that reforms on question papers have direct connection with quality of academics. It was resolved to circulate the report and also plan follow up activities to train teachers in scientific question paper setting and to monitor the transformation.

#### Item No.Q3.18.05: Handbook for Research Scholars

As per decision Q3.17.15, a research handbook has been complied for distribution to all research scholars of the University. The same will be tabled for approval of the IQAC.

**Decision:** Resolved that 800 copies of the Research handbook be printed in Kerala University Press after seeking articles on research through the IQAC members.

# Item No.Q3.18.06: <u>Exceptional Achievement by Student of Optoelectronics</u>

Dr. S. Sankararaman, Associate Professor, Dept. of Optoelectronics has vide letter dt.12.10.2017, reported the outstanding performance of an M.Phil Student M. S. Swapna, Dept. of Opto-electronics doing dissertation under his guidance. During the M.Phil programme, she has published Nine research papers in international journals and communicated Eleven research article. She has Six national seminar papers and has co-authored in Five seminar papers. She is also the co-investigator of one patent application filed by Dr. Sankararaman. She has also passed the online examination of IIT Madras – NPTEL- in Biology. Dr. Sankararaman has remarked that as a teacher of twenty two years of service, he hasn't seen such a hardworking and outstanding student. The case of this outstanding student is brought to the notice of the IQAC.

**Decision:** Resolved that a letter of appreciation be issued to Ms. M.S. Swapna by the Vice-Chancellor.

### ItemNo.Q3.18.07: Award for Innovation in Teaching.

As per scheme approved by IQAC vide decision No.Q3.14.10, applications were invited for Award for best Innovation in Teaching and 4 were received. Vice-chancellor nominated an expert committee to evaluate the applications. The committee evaluated the applications based on presentations and interview and has submitted its report. The same is placed as Appendix. IQAC may consider and decide further action.

**Decision:** Resolved to issue letters of appreciation to all applicants.

#### Item No.Q3.18.08: Suggestion from Alumni to improve Research

Dr. Jithu Unnikrishnan, an alumni of the University of Kerala currently working in IISc, Bangalore, has made certain suggestions to improve research in the University. IQAC may note and decide action on the proposals.

**Decision:** Resolved that the suggestions be acknowledged through a letter from the Vice-Chancellor and proposals be put up in achievable ways before next IQAC.

### Item No.Q3.18.11: ASAP Orientation for Post Graduate Students

Student orientation for Additional Skill Acquisition Programme, was organized at Karyavattom Campus, on 15/9/2017, PG students of different departments were informed through posters and circulars. Poster appended as A3.18.11.





An enthusiastic crowd of 77 students participated in the event and the orientation proved to be very fruitful. The introductory part was handled by Dr. Achuthsankar S Nair, followed by a power point presentation by the ASAP team of Programme Managers. The team explained the structure of skill education system in India, and also elucidated the ASAP University Integration mode. A bouquet of selected skill courses were explained in detail to the gathering. Towards the end, a survey was conducted among students for selecting their choice of course. From a list of 17 courses presented, 3 courses were selected: a) Organic Grower – Agricultural Sector. b) Diet Assistant – Health Care Sector. c) Junior Software Developer (Android) - IT & ES Sector. As of now, minimum registration has been obtained only for the Android Course and steps are on to offer them. The matter is reported to IQAC.

Decision: Noted.

### ItemNo.Q3.18.12: Award for Faculty Webpages

An application for the best faculty web page was received from Dept. of Journalism and it was decided to issue certificate of appreciation to the concerned Dept., vide item No.Q3.14.09. 

The fee for the ASAP shall be as fixed by the Govt, of Kerala from time to time. The students belonging to SC/ST, physically challenged, BPL and SEBC categories are exampled from payment of fee. There will be a relaxation of fee by 25% in the case of students of the APL categories of students who successfully complete the course. All the provision of the University Rules and Regulation shall be applicable with regard to the earning of credits and grades.



#### ORDER

The University of Kerala is the oldest University in the State with a heritage of 80 years. Its history is scattered around in hundreds of documents available in various libraries and official collections. The need for a common University Archives is felt by researchers, media and the University community for a long time. Such an archive is also important for planning, quality studies, gauging progress, and evaluating inherent strengths and weaknesses.

The office of the IQAC has informally collected a number of valuable documents including Souvenirs, Magazines, Newsletters, Bulletins, Directories, Reports, Diaries, Manuals, Proposals, Plans, Budget, Calendars, Books, Photographs etc. Some of these have been contributed from the personal collections of Dr. Achuthsankar S. Nair, the present IQAC Director. The collection has achieved a critical mass and consequently need for securing it and prescribing terms of use has

The IQAC meeting on 18-09-2017 resolved to setup an Archive in the IQAC Office and sanction has been accorded by the Vice-Chancellor to set up the same with the following working instructions.

- 1. The Archive shall be named as "Kerala University Archives" and the Director, IQAC, shall be the custodian of the Archives.
- 2. The Records/documents now available in the IQAC shall be entered in a Stock Register to be maintained for the purpose and shelved with proper indexing.
- 3. These documents, shall be made available to the interested Scholars who do research work in line area, for reference only, on written request.
- 4. No books/documents/records of the Archive shall be allowed to be taken out of the IQAC Office under any circumstances.
- 5. All the interested parties including teaching and non-teaching staff of the University arc free to donate books and records of rare nature and importance related to the University. Current documents also are welcome, so that the Archive also grows forward. All Heads of Teaching Departments and Branch Heads may deposit copies of any document that may be of relevance in future for a student of history of the University. University Engineer may deposit copies of plan drawings of all buildings of the University. Estate Officer may deposit of copics of land deeds.
- Donors of the documents shall be free to refer any of the documents in the Archive with the permission of the Director, IQAC. In the case of others, a nominal fee of Rs. 25/- (Rupees Twenty five Only) per day shall be charged for referring the archives. In the case of teachers and employees of the University of Kcrala, there will be no fee for reference.

- 7. Copies of the documents shall be given on demand on Payment of Rs. 2/- (Rupees Two Only) per page. However, the donors shall be given copies free of cost in respect of documents donated by them (fee shall be charged for the other items as above).
- The fee shall be collected against receipts and the amounts collected shall be deposited
  in a fund called 'IQAC Development Fund' operated by the Director, IQAC. The
  guidelines issued by the University on DDF shall mutatis mutandis be applicable to
  IQAC DDF.
- The Administrative Officer, IQAC shall be responsible for the day-to-day activities such as issue of documents for reference, collection of fee, remittance of fee to DDF, upkeep of accounts etc.
- 10. The details of documents/records available in the IQAC Archive shall be published electronically every year, latest by 15<sup>th</sup> of January.
