Item No.XXVI.05: UGC Net Coaching proposal- Researchers Union

Naveen P.M., Chairperson, Kerala University Research Students' Union 2022-23 has submitted a proposal for conduct of UGC NET Coaching, to be conducted in June 2023. It has been proposed to conduct a total of 20 sessions over a period of 2 months. The Chairperson has submitted an anticipated budget for the programme and requested a financial assistance of Rs. 84,500/- (Rupees Eighty Four Thousand Five Hundred only) for the same. **Appendix III**

Item No.XXVI.06: Software for compilation of necessary documents for Assessment and Accreditation

The meeting of the committee constituted for Compilation and uploading of AQAR 2022 held on 13th April 2023 recommended to initiate necessary action for developing software for AQAR and other relevant document compilation for NAAC Accreditation using the expertise of an outside agency.

The scheme facilitates bringing eminent scholars to our campus, who would interact with our scholars and enrich them in their learning and research activities. Under the scheme, a total amount of Rs. 13,21,000/- to 11 Project Coordinators from various Departments. Item No.XXVI.14: Annual Interdisciplinary Academic Meet-AIAM 2K22

To strengthen the School system in terms of promoting interdisciplinary learning, the Internal Quality Assurance Cell, University of Kerala had invited proposals from various Schools to host

Annual Interdisciplinary Academic Meet–AIAM 2K22, vide a notification dated 31st October 2022. As per the guidelines, the participants would be students, teachers and scholars of the departments under the School. The event can take the form of a workshop, seminar, conference and panel discussion based on a chosen theme considering the disciplines under the School. Resource Persons/invited speakers/experts from outside would act as guest. IQAC would release an amount of Rs. 25,000/- (Rupees Twenty five Thousand Only) per school for the event, expenses beyond the same to be shared by the departments under the School Heads. Four Schools have conducted programmes under the scheme - School of Earth System Sciences, School of Technology, School of Indian Languages and School of Business Management & Legal Studies.

---IQAC Decision---: Noted. Further resolved to explore possibilities for conducting the programme in Schools that have not conducted the Academic Meet so far.

Item No.XXVI.15: Proposal for conducting conference on Quality Framework Benchmarks in association with NAAC

An amount of Rs. 5 Lakh has been sanctioned to the Director, IQAC out of State Plan Funds for the FY 2022-23 towards organizing a conference titled "Three day National Conference on formulating Quality Framework Benchmarks for HEIs". The Hon'ble Vice-Chancellor has accorded sanction to conduct the conference in collaborating mode with NAAC. A proposal has been sent to NAAC in this respect.

Sub: Prevention of Caste-Based Discrimination in Higher Education Institutions (HEIs) -reg.

Madam/Sir,

As you are aware, the University Grants Commission (UGC) has been taking various steps for the Prevention of Caste Based Discrimination in Higher Education Institutions (HEIs). UGC has issued instructions and guidelines for the same vide letters dated 19.07.2011, 02.07.2013, 07.03.2016, 05.09.2016, 15.05.2017, 04.06.2018, 14.09.2020 and 09.09.2021.

The HEIs were requested to comply with the following action points:

- The officials/faculty members should desist from any act of discrimination against SC/ST/OBC students on grounds of their social origin.
- The University/Institute/College may develop a page on their website for lodging such complaints
 of caste discrimination by SC/ST/OBC students and also place a complaint register in the office
 of the Registrar/Principal for the purpose. If any such incident comes to the notice of the
 authorities, action should be taken against the erring official/faculty member promptly.
- The university and its constituent/affiliated colleges should ensure that no officials/faculty members indulge in any kind of discrimination against any community or category of students.
- The University may constitute a committee to look into the complaints of discrimination received from the SC/ST/OBC Students/Teachers and non-teaching staff. The committee shall also include members belonging to SC/ST/OBC category.

You are requested to advise the officials/faculty members of your university/institute to be more sensitive while dealing with incidents of caste discrimination. The above instructions should also be circulated to all the constituent and affiliated colleges of your university for follow-up action.

You are also requested to provide the information for the years 2021-22 and 2022-23 in the prescribed format (copy enclosed) on the University Activity Monitoring Portal (UAMP) of UGC at the link https://ugc.ac.in/uamp/) at the earliest and not later than 30thMay, 2023.

Dear Madam/Sir,

As you aware, in line with the recommendations of the National Education Policy (NEP 2020), the University Grants Commission has notified the University Grants Commission (Academic Collaboration between Indian and Foreign Higher Educational Institutions to offer Twinning, Joint Degree and Dual Degree Programmes) Regulations, 2022 in the official Gazette of Government of India on 2nd May, 2022. The Regulations are available on the UGC website (www.ugc.ac.in).

These Regulations lay down the minimum standards for academic collaborations between the Indian Higher Educational Institutions and Foreign Higher Educational Institutions to offer Twinning, Joint and Dual Degree Programmes.

Such academic collaborations will bring about mobility of students/faculty and promote joint research. These Regulations will make quality higher education accessible to Indian students. Further, the aspiring Indian students will be able to obtain degrees from reputed Foreign Educational Institutions at a fair and modest cost. The employability potential of the students will also be enhanced through global exposure.

In this regard I am pleased to inform you that in order to facilitate the collaboration among Indian and US HEIs, UGC has been designated as the Nodal authority to coordinate outreach activities of Indian universities with US universities. As your institution is eligible to collaborate with the foreign institutions for offering dual/twining/joint degree programmes, you are requested to kindly let us know the possibility of having academic collaboration with the US HEIs. Dear Siri

Teaching through Indian languages is a key area of focus of the National Education Policy 2020. The policy emphasizes the importance of teaching and teaching materials in the mother tongue.

It is heartening to note that textbooks in the mother tongue/local languages are promoted and used by higher education institutions in our country. Teaching is also being imparted in the mother tongue local language in many college and university undergraduate programs in social sciences, commerce, science, etc. This has benefited students from all strata of our society, particularly the disadvantaged sections and those residing in rural and remote areas.

But it is also a matter of concern that the textbooks and study materials are unavailable in local languages for many of the courses in Higher Education, Science, Commerce, and Professional Courses. Hence as a first step in providing quality education in the mother tongue medium as recommended in NEP 2020, it is desired that textbooks may be produced in the mother tongue/local language through writing or translation for the subjects of which textbooks are not available in mother tongue/local language at present.

Promotion of writing or translation of textbooks and teaching process in undergraduate and postgraduate levels in higher education through mother tongue medium will have greater results in improved GER from 27% to 50% by 2035, increased access to disadvantageous social groups, and better reach. Keeping all the above in view, UGC has constituted an apex committee consisting of Wice-chancellors from different states to take the above task forward.

Higher education institutions play a strategic and important role in preparing textbooks and supporting the teaching-learning process in the mother tongue. There is a need to strengthen these efforts and promote such initiatives as writing textbooks in the mother tongue and encouraging the use of the local language in teaching, including translating good books from other languages. We seek your kind indulgence in this matter and request you kindly motivate and encourage higher

education institutions in your State.

May I request you to issue the necessary directions/advisory to the HEIs kindly:

1. To prepare the list of which textbooks/reference books/study material is unavailable in the local language.

2. To identify scholars who can write or translate.

3. To take other necessary actions to support all such endeavors to strengthen the efforts of producing good quality textbooks in the local language and to encourage the teaching-learning process in the mother tongue.
