---IQAC Decision---:IQAC Director reported on SSR compiling work undertaken by the NAAC Directorate-Departments have submitted criteria wise data, the same was compiled and forwarded to conveners of each committee. Scrutiny is in progress

Item No.X.05:Campus Beautification and Infrastructure.

The meeting of empowered committee for infrastructure development held on 24.09.2019 resolved to expedite the following Infrastructure needs as part of the NAAC accreditation.

- 1) Department-wise requirement for campus/building maintenance, upkeep and requirements of classrooms and toilets (list appended, forwarded to Ad BI for action).
- 2) Campus beautification and garden support for teaching departments.

As the matter requires urgent consideration, implementation and execution has to be undertaken on a priority basis, for which a special status need to be accorded.

With regard to (1) above, the matter was discussed with University Engineering Wing and other concerned officers. Based on the deliberation, two options emerged.

- (a) Entrusting the works to the engineering wing and supporting them with necessary human resources and computer facilities, as well as granting administrative sanction on a priority basis for work execution.
- (b) Entrusting the work to an external agency to be identified immediately.

With regard to (2), in order to ensure uniformity and academic environment based customized approach, it was resolved to entrust the work to a single external agency with an expertise in Green Infrastructure and landscaping as well as gardening work.

The Registrar to seek the expression of interest from the external agencies immediately if approved. The University Engineer, Joint Registrar (Campus Administration) to be authorized to release funds allocated in the budget for campus beautification as well as implementation of Green Protocol.

---IQAC Decision---: Resolved to prepare a detailed proposal for infrastructure development in the teaching departments. The Hon'ble members of Syndicate would undertake the visit to the Departments and assess current facilities as well as future requirements considering the upcoming NAAC visit. Campus infrastructure modernization would also be suggested. The members of the Syndicate would be assisted by the following IQAC members:



Memorandum of Understanding

University of Kerala intends to associate with the Higher Education Department, Government of Kerala to impart life skills focusing on holistic development for students.

This would be undertaken under the concept of Greenrooms for Life skills.

The concept

Universities across the globe are under tremendous pressure keeping pace with the rapid disruptions taking place in almost all spheres of human activity and also due to the quantum shifts happening at the human-machine interface. The present generation approaching institutions of higher learning look for an education that would mould them to citizens for the future, but the institutions of higher learning are struggling to break the shackles of traditional systems. Thus, there is a huge gulf between the demands of the future and the delivery capabilities of the Universities and Colleges of our State.

Greenroom for life skills, a first of its kind, would be preparatory centers for offering skills to University students so that graduates pass out with relevant skills for establishing successful careers, be it in research, teaching, industry or the larger world of work. Greenroom will offer students with generic skills such as Communication, Interpersonal skills, Collaborative Problem-solving, Critical thinking, Decision-making skills and Coping skills that would help them adapt to any changes in all spheres of work and also enable them to acquire specific skills relating to their chosen fields of study. As students pass through this in their final semester, they would get opportunities to interact with Scientists, Administrators, Industry experts, Career Counselors and these would also, in the long run, transform into Lifelong learning centers offering short-term modular courses to their returning students/alumni.

Objectives

- 1) Impart life skills to students which would supplement learnings and competencies acquired along with their academic programme so as to make them fit for efficient and effective use of desired capabilities. The specific skills to be addressed are:
 - Communication and interactive skills
 - Behavioral skills
 - Listening skills
 - Writing skills
 - Presentation skills

Implementation Plan

We proposed to role out the scheme in the academic year 2019-20 through setting up of a physical facility comprising of an office room and training hall with multimedia presentation facilities for the Greenroom by the University of Kerala and offering Life skills training of 100 hour (spread over semester 2 and 3) duration to 5-6 batches of students in the second semester. Professional Life skills module developed by ASAP for Advanced Skill Development Centres in Engineering Colleges will be used for the training. Academic preparations for the second year will also be done during the year. The steps can be summarized as:

- a. Setting up of Greenrooms (physical infrastructure) in the University September 2019 under the finishing school.
- b. Finalization of Life skill curriculum (Credit regulations) and training plan to be completed by September 2019 in association with CSS, University of Kerala.
- c. Selection of students for training, 5 to 6 batches of students from Sciences, Social Sciences, Languages and Humanities to be completed by October 2019
- d. Design of specialized discipline oriented skill modules for the year 2020-21 by academic experts from the University and industry/research institutions
- e. Starting of training during the second semester for the selected students 1st November 2019
- f. Monitoring of training by ASAP Programme Manager attached to Greenroom

Life skill training for students by ASAP Skill Development Executives will take place on Saturdays and other holidays (except public holidays) in the Greenroom and classrooms in concerned schools to

which majority of students in a batch (a batch would comprise 30 students) belong to. For each batch of students there shall be a faculty coordinator who will be acting as the link between students and ASAP Programme Manager managing the training. The provision for providing credits based on successful completion of the skilling task through evaluation systems established in this regard would be considered through certification of the same.

Support from University of Kerala

The University would provide the Greenroom facility and infrastructure support in the Kariavattom campus. Services of University teachers would be made available for training based on expertise available specifically in terms of transacting modules in languages. University would arrange for printing and distribution of study materials. University would draw inputs from industry and other research institutions specifically through: IQAC, Placement Cell, Career Guidance Bureau, Centre for Academic and Industrial Collaboration and Research Council, these inputs would be shared with trainers of ASAP for possible integration into the skilling programme. University to support in the assessment of skill acquired, issue of certificates and gradation of successful candidates. University would have no financial implications in terms of outward payments on any account for services rendered by ASAP.

Support from ASAP, Higher Education Department, Government of Kerala

The overall implementation monitoring and running of the programme would be as per ASAP guidelines and under the provisions of the Higher Education Department, Government of Kerala. Support from ASAP would involve, setting up of greenrooms, finalization of life skill curriculum, design of specialized discipline oriented scheme modules, identification of programme managers and providing their services to the University, monitoring the training programme, providing services of trainers as required for the various life skill components.

Review of progress under the skilling programme would be jointly undertaken by University of Kerala and ASAP. Each programme would culminate with imparting intensive finishing skills. Based on inputs received in the review, necessary modifications may be introduced in the curriculum, training mode and other transactions.

One teacher from teaching department, nominated by the department concerned, would be included .


Pre workshop orientation

Each department need to examine their current curriculum and identify possible skill gaps, learning deficiencies in terms of inability to attain outcome envisaged and gaps in terms of current needs of the society, industry and higher learning Institutions. The list of experts who could address these gaps may also be discussed and submitted. The outcome from the department level discussions and the probable new areas which could bridge the gap need to be documented, approved by the Department Council and submitted to IQAC by 31st of October. This document would act as the Basic Frame work for the work shop. Experts would address the same in consultation with our teachers at the workshop The workshop may be tentatively scheduled for the 3rd week of November 2019.

University of Kerala: A UNIVERSITY WHICH BELIEVES IN MANTRAS OF LEARNING, GROWING AND INNOVATING

niversity of Kerala, formerly known as University of Travancore is the 16th University in India. It was established in 1937 by a promulgation of Maharaja of Travancore, Sri Chithira Thirunal Balarama Varma. He was the first Chancellor of the University and Sir C.P. Ramaswamy Aiyar, the Diwan of state at that time, became the first Vice-Chancellor. During that period, there were ten colleges in Kerala which were affiliated to Madras University. After the inception of the University of Kerala, these colleges got new affiliation under the new university. Imparting education with a focus on access, equity, and social cause, the university is providing standard education that focuses on increasing research activities among the students to fulfill the societal needs and is striving to attain the status of a world-class institute through transformational learning and innovation keeping the needs of the masses at the core.

Unique Curriculum in Traditional Courses

The university curriculum offers a wide array of courses at Post Graduate, M. Phil. and Ph.D. levels. Considering contemporary and latest industrial developments, the course curriculum is revised at least once in three years after taking feedbacks from professional



bodies and policy-making agencies. Currently, the University of Kerala has 183 affiliated colleges under its name and 42 teaching and research departments under 11 schools that provide 100 percent funding for research scholars. The 183 affiliated colleges include 102 Arts and Science colleges (13 Government Colleges, 38 aided and 51 unaided institutions). There are six Law colleges (1 Government, 1 Private and 4 unaided), 49 Teachers' Training Colleges (one Government, six aided and 43 unaided), two Fine Arts Colleges (Government), one Music College (Government) and one College of Physical Education. More than 40 percent of the departments are supported by external funding agencies like UGC-SAP and FIST.

University of Kerala has excellent infrastructure and well-equipped research laboratories, astronomical observatory, publications division, own press, and socially integrated student support services. In order to encourage interdisciplinary research, the institute has a State-of-the-Art Sophisticated Instrumentation Centre with advanced equipments. As per digitalization of education, the university launched its first Massive Open Online Course (MOOC) and this was yet another landmark achievement in 2017. "The support mechanism for research and innovations that we provide to our students are in the form of Research Council, Institution Innovation Cell and IPR Cell. Drawing from the best practices globally, we have a flagship scheme on 'Interaction with Eminent Scholars' to help the students grow and thereafter, we recognize the talented students through our initiatives like Talent Bank, Award for highest Project Funding and Best Thesis Award. Without the professors, it is impossible for the students

to perform, thus, we have introduced Best Teaching Department award to showcase the professors' hard works," asserts Prof. V.P Mahadevan Pillai, Vice-Chancellor, University of Kerala. He continues, "We address employability and skilling issues by bridging skill gaps through Finishing School programs. In addition to this, we propose to associate with ASAP (Additional Skill Acquisition Programme) with an objective to make the students industry ready.

A Place among the Bests

University of Kerala was reaccredited by NAAC with 'A' Grade in January 2015. It has won the first-ever Chancellor's Award for the best University in the state instituted by the Hon'ble Governor Justice P. Sathasivam in the year 2014-15. The university was ranked 22nd among the universities and 35th among Higher Education Institutions across the country under National Institutional Ranking Framework (NIRF) of 2019. One of the distinguished achievements of the University in 2017was that they found a place in the world ranking of Universities and was placed in the 801 – 1000 band by Times Higher Education Network. The university has been host for the Indian History Congress, Indian Science Congress, Indian Commerce Association as well as the Indian Accounting Association and this has added another feather to the cap.

Students of the University of Kerala are also well known for extra-curricular activities. "We have a mega youth festival where 6000+ students participate in 100+ events. All our teaching departments have clubs like a literary club, skill acquisition club, media club, commerce club, etc. All these

activities enhance the soft and hard skills of our students. These activities develop a competitive spirit among the students," explains Prof. Mahadevan. He further adds, "Not only extra-curricular activities describe our students' potential. We have associated with Kerala Start-Up mission on incubating business ideas and have a technology-based start-up center named KU-TBSC (Kerala University Technology Business Start-Up Centre). We have also collaborated with Institution Innovation Cell of MHRD and Kerala Development and Innovation Strategic Council (K-DISC) for giving life to innovative ideas."

The Future Road Map

The roadmap of University of Kerala is designed to facilitate education through investments in infrastructure, sports, and student welfare programs. They want to take advantage of global as well as national support for research and innovation to convert teaching-learning facilities to technology-enabled learning systems, breaking boundaries of time and space.

University of Kerala wants to create a massive online learning channel with facilities for content creation, dissemination, training, and development. The university also plans to setup a human resources and skill development center ensuring brain gain and inward mobility of talent. With a bull's eye, the university is aiming to increase students' strength to 6000 and faculty strength to 600. Increasing funds to at least two percent from consultancies and providing support to students' start-ups is another story they want to illustrate in the coming future.
